Further, BSE vide its letter to the company bearing reference no. L/SURV/OFL/KM/2021-2022/SHELL/COMP/532072/FO dated 31st March, 2022 and Notice No. 20220331-16 dated 31st March, 2022 has moved out the securities of the company from "Stage 3" of GSM framework w.e.f. Friday i.e., April 01, 2022 and has also revoked the restrictions on the Promoters and Directors of the company, imposed earlier by it vide its interim order dated January 15, 2018, w.r.t. selling of their existing holding in the Company.
